### Sub: Continuation of trading in securities in Z Category

Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020, Members of the Exchange are hereby informed that the below mentioned Companies have been identified as non-compliant with Regulation 33 (i.e., Submission of Financial Results) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (Listing Regulations) for two consecutive quarters' i.e., December 31, 2021 and March 31, 2022.

Therefore, the trading in securities of these companies is eligible to be transferred to 'Z' Category ('Z' Series) with effect from August 08, 2022 for the said non-compliance.
