Sub: Settlement Parameters and Reports structure for T+1 Settlement in Capital Market Segment

This is further to circular no. NCL/CMPT/49974 dated October 14, 2021 and joint Press release dated November 08, 2021 issued by the Exchanges and Depositories on ‘Roadmap for introduction of T+1 rolling settlement cycle in equity market’.

1. Settlement Parameters for T+1 Settlement

Securities under T+1 settlement shall be cleared and settled with settlement type and settlement number distinct from the settlement type and number for securities with T+2 settlement. Members are required to do EPI of securities, pay-in of securities in the respective settlement type and numbers.

1.1. Settlement Types

Settlement Type	Settlement Type	CDSL*	NSDL*
Normal	M	23	49
Trade For Trade	Z	24	50
ITP for SME	B	25	51

*Members are requested kindly refer to the communication issued by depositories in this regard.

1.2. Settlement Number

Settlement number for T+1 settlement shall be distinct from T+2 settlement. Actual Settlement calendar shall be made available as part of the circular issued on monthly basis.

Example-

Trade Date	Settlement Number T+2	Settlement Number T+1
25-Feb-2022	2022039	2022539
28-Feb-2022	2022040	2022540
01-Mar-2022	2022041	2022541

2. Auction for Shortages

In respect of security shortage, Clearing Corporation shall conduct auction for the same as per extant rules in the existing auction market along with shortages of T+2 settlement.

The Auction settlement type and number for auction conducted for shortages in T+1 and T+2 shall remain same.

Example -

Settlement Cycle	Trade Date	Settlement Date	Settlement Number	Auction Trade Date	Auction Settlement Date	Auction Settlement Number
T+2	25-Feb-22	01-Mar-22	2022039	01-Mar-22	02-Mar-22	2022039
T+1	28-Feb-22	01-Mar-22	2022540			

As per above example, Auction conducted on March 01, 2021 shall be settled in settlement type "A" and settlement number 2022039. Actual Settlement calendar shall be made available as part of the circular issued on monthly basis.

3. Reports

The revised formats for existing report i.e. Applicable Symbol is provided in **Annexure I**. There shall be additional column for settlement flag indicating applicable settlement cycle for a security.

Separate reports shall be provided with settlement type and number for securities settling on T+1 basis as per **Annexure II**. There are no changes in existing file format for these reports.

List of report in which no changes on account of T+1 settlement mechanism is as per **Annexure III**. Information pertaining to trades executed for securities settling on T+1 and T+2 shall be incorporated in same reports.

The members are requested to take note of the same.
